

Legacy Legend Fund

When a donor makes an unrestricted gift of \$100,000 or more, or when a Legacy Hero Fund reaches \$100,000 a Legacy Legend Fund will be created.

Earnings each year will be used to fund a specific community project with the donors having opportunity if they choose to make the award. A professional family photograph will be displayed on the Legacy Wall of the Foundation offices.

Although no additional gifts are required to keep any Legend fund active, donors are encouraged to consider future gifts (perhaps annually) to further the Legacy's impact in Greene County

Leaving a Legacy

Donors have established more than 100 funds within the Foundation with the earnings funding grants to Greene County charities each year forever. A \$500 gift will begin a legacy fund and can be added to in any amount. All gifts are tax-deductible and can be funded with cash, securities, or real estate.

Legacy 500 Fund

An unrestricted gift of \$500 or more will make donors a member of the Legacy 500. A gold nameplate will be placed with the Legacy 500 member or honoree on the Legacy Wall in the Foundation Offices. Subsequent gifts can be made to the fund in any amount at any time. Investment earnings from the Legacy 500 gifts are used to fund charitable community needs throughout Greene County.

Although no additional gifts are required to keep any of the Legacy funds active, donors are encouraged to consider future gifts (perhaps annually) so the Legacy's impact will continue to grow in Greene County.

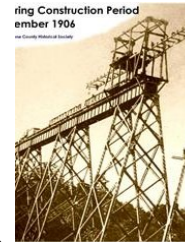

A lasting legacy

Legacy Hero Fund

A donor who makes an unrestricted gift of \$10,000 or more, or when gifts to a Legacy 500 fund reach \$10,000 a Legacy Hero Fund is created in the donor's name. A Legacy Hero Fund is a "stand alone" unrestricted endowment fund from which a portion of annual earnings (usually between 3-5% of the fund balance) are granted in the name of the Hero Fund each year.

Subsequent gifts can be made to the fund in any amount at any time. A crystal plaque with the donor's name will be placed on the Legacy Wall in the Foundation's offices.
